## Current Posture: 3A “Surge”

## Update Message

It has been a busy two weeks at FMFCB! On the 21<sup>st</sup> of Oct, we successfully completed *HARRY DEWOLF*'s Technical Assistance Visit. This was the first opportunity for FMFCB to work on this new class of ship and we tackled the situation with enthusiasm and technical competence. FMFCB completed over 75 jobs and provided a key solution to a water ingress problem of the anchor cable hawse pipe, demonstrating our responsiveness to quickly solve problems for the Fleet. *OTTAWA* continued its EDWP2 where the focus is on system installation and reactivations in order to result in having OTT ready for sea by April 2022. *REGINA* successfully completed EWP2 and on 20 Oct, transitioned into a 12 month Docking Work Period conducted by ADM(MAT). On the submarines side, we commenced phase 1 of *VICTORIA*'s work period 202 which is a very short 11 day project to enable operations at sea. Finally, we continued to provide support to *CORNERBROOK*'s Tiered Readiness Trials. Well done FMF!
